ORDER:-

Whereas the Government have issued guidelines in the reference 1st read above for allotment of surplus land which were taken possession under the provisions of principal Act,1976 and saved under section 3(1)(a) of the Urban Land Ceiling Repeal Act, 1999.

2. Whereas, the Special Officer, Urban Land Ceiling, Guntur vide reference 2nd read above has submitted proposal based on the application filed, for allotment of excess land taken possession by the State Government under the provisions of the Principal Act, 1976 and under occupation of 3rd parties with a view to regularize the un-authorized occupation.

3. Accordingly, the Government after careful examination of the proposals hereby allot the excess land taken possession by the State Government under the provisions of the Principal Act, 1976 to an extent of 60.96 Sq. Mtrs in D.No.678/A1 of Guntur under occupation of 3rd parties in favour of Sri Bandi Venkata Rao S/o. Koteswara Rao who is reported to be in possession of the excess land.

4. The allotment of excess land is at free of cost which shall be heritable but not alienable for a period of (10) years from the date of this order.

5. The name of the allottee Sri Bandi Venkata Rao S/o. Koteswara Rao shall be incorporated in Revenue, Registration & Survey records accordingly by the authorities concerned. The Chief Commissioner of Land Administration and the Commissioner & Inspector General of Registration & Stamps shall ensure compliance of these orders.
