#### ORDER:

The draft variation to the road network envisaged in the notified Metropolitan Development Plan-2031 approved vide G.O.Ms.No.33 MA&UD dt:24.01.2013 issued in Government Memo 7<sup>th</sup> read above, was published in the extraordinary issue of the Telangana Gazette No.107,dt:29.05.2019. It is reported by the Metropolitan Commissioner, Hyderabad Metropolitan Development Authority, Hyderabad that a public notice has been issued inviting objections and suggestions in News Papers i.e. 1) Hans India (2) Andhra Jyothi(Both in Hyderabad edition) on 15.07.2019 and no objections or suggestions have been received from the public within the stipulated period. Hence, the draft variation is confirmed.

- 2. The following notification shall be published in the **next issue** of Extra-ordinary Telangana Gazette.
- 3. The Metropolitan Commissioner, Hyderabad Metropolitan Development Authority, Hyderabad shall publish a notice in newspapers as specified in sub-section (3) of Section 15 of HMDA Act, 2008 on or before the date of Gazette Notification and furnish the copies of same to the Government.

# **NOTIFICATION**

In exercise of the powers conferred by sub-section (1) of section 15 of Hyderabad Metropolitan Development Authority Act, 2008 (Act No. 8 of 2008), the Government hereby makes the following variation to the road network envisaged in the notified Metropolitan Development Plan-2031 approved vide G.O.Ms.No.33 MA&UD dt:24.01.2013, as required by sub-section (1) of the said section.

#### **VARIATION**

The proposed 100 feet wide Master plan road passing through Sy.Nos.235,236,237,264,265,267,268,269,271,262,261&260 of Manchirevula(V), Rajendranagar(M) Old, Gandipet(M) new, RR Dist approved vide G.O.Ms.No.33, MA, dt:24.01.2013 for (MDP - 2031) is now deleted (marked as A to D in extract) in lieu of another existing road is proposed to be widened to 100 feet wide road, subject to the following conditions:

- 1) HMDA shall collect the proportionate conversion charges from the applicants while granting Building Permission to the extent of area now deleted.
- 2) The owners/applicants are solely responsible for any mis-representation with regard to the ownership/ title, Land Ceiling clearances etc., and they will be responsible for any damages claimed by anyone on account of change of land use proposed.

- 3) The applicant shall comply with the conditions laid down in the G.O.Ms.No.168, dt:07.04.2012 & G.O.Ms.No.33, dt:24.01.2013 as amended from time to time.
- 4) If any dispute occurs regarding ownership of the applicant will be the whole responsible for that.
- 5) The Change of Land Use shall not be used as the proof of any title of the land.
- 6) The applicant has to fulfill any other conditions as may be imposed by the Competent Authority.
- 7) The change of land use doesn't bar an y public agency including HMDA/Local Authority to acquire land for any public purpose as per law.
