ORDER:-

In pursuance of the Notification No. S.O.2733 (E), issued by the Ministry of Environment, Forests and Climate Change dated: 30.07.2019 in the reference read above, State Government of Telangana hereby notify the Agency to lookafter secretarial functions for the effective functioning of the State Level Environment Impact Assessment Authority Telangana (SEIAAT), and the State Level Expert Appraisal Committee Telangana (SEACT) constituted for the Telangana State under Environment (Protection) Act, 1986 (Act 29 of 1986).

2. Accordingly, the following notification shall be published in an Extra-Ordinary issue of the Telangana State Gazette, Dated:09.08.2019.

NOTIFICATION

In exercise of the powers conferred by paras 9 and 10 of the Notification No.S.O.2733 (E), issued by the Ministry of Environment, Forests and Climate Change, Government of India, dated.30.7.2019 the Government of Telangana hereby notify the Telangana State Pollution Control Board, to act as the Agency to act as Secretariat for the State Level Environment Impact Assessment Authority Telangana (SEIAAT), and the State Level Expert Appraisal Committee Telangana (SEACT), so as to provide all financial and logistic support including accommodation, transportation and such other facilities in respect of discharging their statutory functions.

3. Further, the Telangana State Pollution Control Board shall arrange to pay sitting fee, traveling allowance and dearness allowance to the Chairman and Members of the State Level Environment Impact Assessment Authority Telangana (SEIAAT), and the State Level Expert Appraisal Committee Telangana (SEACT), shall be paid as per the rules of the Government of Telangana.
