ORDER:

Whereas, by Section 101 of the Andhra Pradesh Reorganization Act, 2014 (Central Act No. 6 of 2014), the appropriate Government i.e. the State of Telangana is empowered by order, to make such adaptations, and modifications of any law (as defined in Section 2(f) of the Act) made before 02.06.2014, whether by way of repeal or amendment as may be necessary or expedient for the purpose of facilitating the application of such law in the State of Telangana before expiration of two years from 02.06.2014; and there upon every such law shall have effect subject to the adaptations and modifications so made until altered, repealed or amended by a competent legislature or other competent authority.

2. And whereas, the Andhra Pradesh Labour Welfare Act, 1987 was in force as on 1.6.2014;

3. And whereas, after careful examination, Government have decided to adapt the Andhra Pradesh Labour Welfare Fund Act, 1987 as amended from time to time with necessary modification, so as to facilitate its application to the State of Telangana.

4. Accordingly, the following notification will be published in an Extraordinary Issue of the Telangana Gazette, dated: 06.02.2016.

NOTIFICATION

In exercise of the powers conferred by section 101 of the Andhra Pradesh Reorganization Act, 2014 (Central Act No. 6 of 2014), the Governor of Telangana hereby makes the following order, namely,

1. (1) This Order may be called Andhra Pradesh Labour Welfare Fund Act, 1987 – (Telangana adaptation) Order 2014.

(2) It shall be deemed to have come into force w.e.f. 02.06.2014.

2. In this Order, the “law” i.e. “Andhra Pradesh Labour Welfare Fund Act, 1987” being adapted in this order, shall have the same meaning as defined in section 2 (f) of the Andhra Pradesh Reorganization Act, 2014 (Central Act No. 6 of 2014).

3. The Andhra Pradesh General Clauses Act, 1891 applies for the interpretation of this order as it applies for the interpretation of a State Act.

4. In the Andhra Pradesh Labour Welfare Fund Act, 1987:

- (1) throughout the Andhra Pradesh Labour Welfare Fund Act, 1987 for the words "Andhra Pradesh" (occurring otherwise than in a citation or description or title of other laws including the Rules as the case may be), the word "Telangana" shall be substituted.
- (2) in section 4, in sub-clause (ii) of clause (b) of sub-section (3), for the words "Nutrition and Technical Education", the words "Training & Factories" shall be substituted.
- (3) in section 8, in clause (b) of sub-section (3), for the words "Andhra Pradesh" the word "Telangana" shall be substituted.
- (4) in section 37, in sub-section (3), where ever the words "Legislative Assembly" occurs, the word "Legislature" shall be substituted.
- (5) in section 40, in the proviso, for the word "Workmen", the word "Employees" shall be substituted.

5. As from the appointed day, the Andhra Pradesh Rules mentioned in the Schedule to this Order, shall, until altered, repealed or amended by the competent Legislature or other competent authority, have effect subject to the adaptations and modifications directed by that Schedule.

6. For the purpose of this Order, and the Act and Rules adapted herein, the expression "the State" shall have the meaning and area as specified in Section 3 of the Andhra Pradesh Reorganization Act, 2014.
